Terms and Conditions:

1. Caution Deposit of institute and hostel will be refunded only on successful completion of the course after settlement of all accounts. Non-completion of course for whatever reason(s) will lead to forfeiting of the Caution Deposit. The caution deposit shall be claimed within three years from the date of declaration of final semester result by obtaining final clearance from all departments, failing which the same shall be forfeited.
2. If the students are suspended / terminated from the institute/hostel on disciplinary cases, the entire fee paid for the semester will be forfeited.
3. During the time of admission, nominal extra charges for books, tool kits, insurance and uniforms will be levied and supplied to the students.
4. Institute reserves the right to change the fee structure in subsequent years.
5. Fees will be collected semester wise in advance (July & January) every year. Delay in payments will attract fines.
